my wife Cassie and my daughter
Brianna dead on the living room
sofa.

POLICE
Do you have any idea who could have
done this?

INT. POLICE STATION-EVENING

Ron goes down to the police station for more questioning. He takes a polygraph and passes, and a DNA test.

A month later he gets results stating that he is negative. He is no longer considered a suspect.

INT. RON'S HOME-LIVINGROOM-DAY

RON

I must find out who murdered my
wife and daughter.

There is a knock on the door and it is his friend ERIC.

Eric is an African American male about 6 feet, 180 pounds with a low haircut. He looks about 50 years old.

ERIC

ERIC

(CONT'

Who could've done this to you Ron?
Why would anyone would want to
murder Cassie and Brianna?

RON

(Crying) Some sick ass motherfucker
that's who would have done this.

'D)

RON

(CONT

It's been a month and since the
murders, and I have not heard
anything.

ERIC

The cops questioned me too,

remember? I took a DNA test and a polygraph test and I passed all of them. I was cleared of being a suspect as well.

RON

I got to find out who killed my family? Eric, I need your help.

ERIC

Oh, you already know, I got your back always.

Eric leaves Ron's home and tells him that he has to go to work and he will come back later after he gets off.

RON

DEVON

RON

RON

I found an email in our computer.
You wrote her a nasty note about

RON
(CONT
I believed you are the one who
killed my wife.

DEVON
I am so sorry about what happened
to Cassie , but I did not kill your
wife.

RON
Why the fuck were you emailing my
wife when you knew she was
married.

DEVON

Listen man, I had a crush on your wife and I thought I had a shot to get with her. She told me that she was happily married and loves her husband so I stopped emailing her.

RON

Ron walks away and leaves Cassie's

job. **INT. RON'S HOUSE LIVING ROOM-DAY**

RON

(Calls Eric) Eric, man I went to Cassie's job and I spoke with that Devon dude.

ERIC

RON

(CONT

ERIC

(CONT'

I think the person or people who killed Cassie and Brianna had nothing to do with a man having a crush on Cassie. I think this is more sinister than what you think.

(CONT'

You got to do more research because I doubt if a jilted man who got rejected could have killed your family.

RON

All I know is that Devon dude is a scum bag and If it is him, I am going to delete him.

RON

(CONT

You are right though, I'm going to do more research into who could have killed my wife and daughter.

Ron hangs up the phone with Eric.

There is a knock on the door and it is Cassie's friend named Leslie. She is there checking on Ron.

Leslie is a petite African American. She is dark skinned with a CUTE pixie cut, about 5'3 weighing at least 105 pounds.

RON

RON

(CONT'

Chris is just a boy. I don't think
he did that, I think it is deeper

crush on a boy.

Eric and Ron end their conversation.

EXT. CAROL JONES HIGH SCHOOL-DAY

Ron goes to the Brianna's high school named CAROL JONES HIGH
SCHOOL.

and Ron decides to pay Chris a visit.

He sees Chris leaving the campus and walking down the street.

Ron drives right next to him with a gun in his hand and he
starts pointing the gun towards Chris.

ERIC
(CONT'

RON
Well, hell, what would you do if someone murdered your family.

ERIC
Look, I know I don't have a family , I'm not married or don't have any children, but I know I would not be going out of my mind and losing a grip on reality.

RON
I want answers to my family's murder.

(CONT

Could you please leave now Dennis, don't come back until I let you know more details about Cassie and Brianna's murder okay?

Dennis does not respond back and he leaves Ron's house.

Ron sees his laptop and sees a message again about owing them some money.

INT. LIVING ROOM RONS HOUSE -

RON
(Talking to himself)I don't owe

anyone any money. Cassie, you got mixed up into something dangerous.

'D)

RON

(CONT

Dennis is getting on my nerves, got the audacity to give my wife a red rose and a note.

Ron starts thinking to himself about that message that keeps popping up on his laptop. He tries to remember if Cassie owed anybody any money.

Ron cell phone rings and it is an anonymous call telling him he owes them money. Ron hangs up his cell phone and starts cursing.

'D)

RON

(CONT

Who the hell do they think they are saying I owe them some money. I don't owe anybody anything.

'D)

RON

(CONT

I wonder if Cassie was on drugs and she owes some drug dealers money.

'D)

RON

(CONT

That's ridiculous because Cassie never did any drugs whatsoever. She was too good to be a drug addict.

Ron starts playing a video game called HITMEN FOR HIRE. As, he plays the video he tries to remember who could have possibly killed Cassie and Brianna.
